“The Parish Council does not object to the proposal; however, it would encourage the Planning Authority to note that:

1. There are many more buildings currently on site than are shown in the plans provided.
2. The proposed building plan is inaccurate as a ‘turning out area’ should be external, so the label on that part of the stable is incorrect.
3. A waste management plan is included in the application but the facility described in it does not form part of the proposal.”
