Annex 4 - Conditions Consistent with the Operating Schedule

General - all objectives

- 1. The hall will be well managed under the auspices of a statutory authority.
- 2. Suitable policies and monitoring procedures will be in place.
- 3. Training will be provided to paid and volunteer staff.

Prevention of Crime & Disorder

- 4. The hall will be securely locked.
- 5. There is good oversight from surrounding houses. CCTV will be considered if justified.
- 6. Diversionary activities will be provided at the hall.

Public Safety

- 7. A health and safety policy will be in force and hirers will be made aware of it.
- 8. PAT testing will be carried out as required by law.
- 9. Outside caterers will be required to be registered as Food Businesses and have suitable hygiene certificates in place.

Prevention of Public Nuisance

- 10. Town and Country Planning conditions dictate that doors may not be open when loud music is played.
- 11. Users will be advised to leave the premises quietly.
- 12. Walking and cycling to the venue will be encouraged reducing car noise.

Protection of Children

- 13. Hall hirers operating events or facilities for children will be required to have a suitable safeguarding policy in place.
- 14. Events that are unsuitable for children will be strictly controlled.
